- There is an extra \$10.00/class fee for those who are not Commons residents or Bath & Tennis members. Cress Creek Commons residents/Bath & Tennis members will be given first priority.
- Classes that do not meet the minimum enrollment will be cancelled. All monies for classes that are cancelled will be refunded in full.
- Participants may have to change classes based on ability. This is at the coaching staff's discretion.
- If classes are cancelled due to inclement weather (rain or excessive heat), these days will be made up. **However, there is a maximum of 2 make-up days per session.** What constitutes inclement weather is determined by the coaching staff. Make up days for session 1 will be: June 28<sup>th</sup>-July 8<sup>th</sup>. Make up days for session 2 will be: August 2<sup>nd</sup>-August 9<sup>th</sup>. You will be informed in advance of the exact days/times of make-up days should they be necessary.
- Due to the need for advanced planning (staffing, equipment purchases, scheduling, etc.) there will be no refunds granted. Exceptions to this rule will be based on extreme circumstances as determined by the coaching staff.
