NAHC Strives to Inform Voters Prior to the Spring Elections

Part of the Confederation's mission is to create a medium for homeowner concerns and interests while also developing and maintaining relationships with all levels of government. In keeping with this direction, we have scheduled a series of pre-election candidate forums for contested races in the upcoming April general elections that have significant impacts on our property tax bills. Three have been completed and two more forums have been scheduled on:

- March 7 School District 204
- March 13 City Council

Forums are held in the City Council Chambers of the Naperville Municipal Center, 400 S. Eagle Street, and will begin at 7:00 PM. NAHC Forums are

open to a live audience in Council Chambers, and are broadcast live over both cable television and the Internet with replays also scheduled during the weeks prior to the elections. We encourage community attendance at the live event, as this is the means to get your questions into the discussion.

In March, we will quiz candidates for the Indian Prairie District 204 Board of Education and the Naperville City Council.

Previously, on February 12th, the Confederation took an in depth look into whether or not part of the Naperville City Council should be elected on a district, rather than completely at-large, basis. We also met the candidates for Community School District 203 Board of Education on February 27th.

In January, our Moderator, Kathy Benson, and panelists Superintendents Kathy Birkett and Dan Bridges; Mary Anne Buckman, Dr. Jen Hester, and Kathy Duncan provided their insights on the changes Common Core Standards will make in our schools.

Forums are telecast on the City of Naperville Government Access Channel, WCNC (6-WOW, 10-Comcast, 99 – AT&T) and streamed live and available for on-demand viewing on the City's website at www.naperville.il.us/granicus.html. Check the WCNC schedule for replays or go on line to check them out.

If you are unfamiliar with our forums, our tried and true format includes candidate opening statements followed by answer one or two opening questions posed by the Confederation. Audience questions collected during the forum are then posed by our moderator to the candidates.

The Confederation asks that audience members observe and follow a few guidelines when submitting their questions:

- 1. Frame your questions so that all candidates/participants may have an opportunity to answer, rather than asking directed specific auestions of panel example, members. For acceptable question would "What is your position on issue XYZ?" Conversely, unacceptable question may be "Candidate John Jones, is it true that your position on issue XYZ is ...?"
- 2. Ask questions that can reasonably be answered within 30-45 seconds. That is the time that will be available to ensure

3. Try to frame questions as simply and directly as possible. While some questions may require an introductory statement, these statements should be as brief as possible. Questions that amount to prolonged speeches may not be asked as presented.

District 203 Announces Major Community Outreach Effort

At the February 19th District 203 Board of Education meeting, Superintendent Dan Bridges announced an extensive community outreach effort to chart the future direction of the District.

It is no exaggeration to say that public education is in a period of massive change. From the implementation of the Common Core and the PERRA assessments, to the new teacher and principal evaluation regime created by the PERA act and SB7, to the ongoing challenges with state and national funding, for District 203 to prosper and improve, the district must come to a clear understanding of where it needs to be in five years and outline the steps it will take to get there. This effort is designed to do just that. The District is interested in hearing from all members of the community, not just parents with children in the system.

The public is invited to attend an open house to provide comments about traffic concerns related to **Zone 11 of the City's Neighborhood Traffic Study Program**. Zone 11 is bounded by Edward Hospital on the north, Washington Street on the east, 75th Street on the south and West Street on the west and includes Olympic Terrace, West Highlands, Hobson West and Maplebrook I.

The open house will be held from **5:30 to 7:30 p.m. on Thursday, March 7** in the gym at Elmwood Elementary School, 1024 Magnolia Lane. The purpose of the meeting is to allow the public to provide the City with their questions and concerns related to traffic conditions in Zone 11. This is an open house event; no formal presentation will be provided. For those not able to attend, the exhibits will be posted on the project webpage at www.naperville.il.us/zone11.aspx following the open house. Comments are encouraged and will be accepted via email through 5 p.m. on Monday, March 18.

Beginning this year, the City of Naperville is working with consultants to implement a new Neighborhood Traffic Study Program, which will address traffic conditions within identified neighborhoods in the City in a comprehensive manner rather than on an individual request basis as has been done in the past. Every year, the City receives numerous resident requests to investigate traffic issues such as speeding, cut-through traffic, pedestrian safety and parking concerns.

Through the Neighborhood Traffic Study Program, the City will evaluate and address neighborhood traffic concerns programmatically on a comprehensive neighborhood-wide basis. Using the City's Master Thoroughfare Plan map, the City has identified 33 neighborhood study areas and anticipates completing one to three studies a year until all the study areas are completed. The City of Naperville is accepting comments on proposed federal energy standards through March 19, 2013. In the interest of transparency and convenience to utility customers, the City will accept written comments during this time as well as host two public hearings in March 2013.

The proceeding is being conducted in accordance with the Public Utility Regulatory Policies Act (PURPA) to consider proposed federal energy standards and decide whether the City should implement these proposed standards or decline to do so. The proposed federal energy standards include net metering, fuel sources standards, fossil fuel generation efficiency standards, interconnection standards, smart metering (with time-based rate schedules), integrated resource planning, rate design modifications and smart grid information.

The utility staff has its proposed findings on each federal energy standard available for public review at www.naperville.il.us/utilityhearing.aspx as well as in hard copy form at the City Clerk's Office at the Naperville Municipal Center, 400 S. Eagle St.

Multiple methods are available for the public to comment on these standards. Written comments will be accepted through March 19, 2013, by emailing lafeberp@naperville.il.us. Comments can also be mailed or submitted in person to City Clerk's Office, Attn: Pam LaFeber/PURPA Comments, Naperville Municipal Center, 400 S. Eagle St., Naperville, IL 60540. Full rules on what written comments should include are available to view atwww.naperville.il.us/utilityhearing.aspx.

In addition, two public hearing dates for the public to attend and provide verbal comments are set. The hearings will take place from 3 to 7 p.m. on Monday, March 4, 2013, and 10 a.m. to 4 p.m. on Tuesday, March 19, 2013, in Council Chambers at the Municipal Center. Both hearings will be broadcast live on the City's government access TV station WCNC (Ch. 6 – WOW, Ch. 10 – Comcast and Ch. 99 – AT&T) as well as stream live via the City's website at www.naperville.il.us/granicus.html.

Full rules on how public hearings will work and how public participation can occur are available at www.naperville.il.us/utilityhearing.aspx. Members of the public interested in attending the hearing and submitting public comments are encouraged to review the hearing rules in advance. Those customers

wishing to intervene in the proceeding as an "interested party" may provide evidence, rebuttal testimony or cross-examine witnesses must have already filed a notice with the City Clerk's Office. Members of the public will be allowed to comment at the hearings; however, if not registered as an interested party they cannot provide evidence, rebuttal testimony or cross-examine witnesses.

All written comments and those received at the public hearings will be available for review at www.naperville.il.us/utilityhearing.aspx. Following the hearings, all testimony, comments and evidence will be summarized and make a recommendation to the City Council in the form of a resolution. The resolution will be discussed at a future City Council meeting for final action.

The City of Naperville is proud to announce that it has received an A+ transparency grade from Sunshine Review, a non-profit organization dedicated to state and local government transparency. This ranking outscored all other major cities in Illinois and the State of Illinois itself.



SUNSHINE REVIEW In looking at the City's website, the Sunshine Review 10-point transparency used its checklist determined it contained thorough information on the

budget, meetings, elected officials, administrative officials, building permits and zoning information, audits, contracts, lobbying, public records and taxes. Naperville has information posted on all of these topics at www.naperville.il.us. More information about the Sunshine Review and its transparency checklist are available at http://sunshinereview.org/core/.

Recently, the City also put together a webpage solely devoted to government transparency to highlight important information and provide residents with a better idea of how their tax dollars are spent. Finance and Human Resources information, including an innovative analysis of the City's expenditures known as "spotlight on spend" and lobbying contracts.

Coming In May - NAHC Elections

In accordance with our bylaws, the Naperville Area Homeowners Confederation will hold elections at the Confederation Annual Meeting, scheduled for Saturday, May 18, 2013 at 8:30 AM in Meeting Rooms B&C of the Naperville Municipal Center, 400 S. Eagle Street, Naperville, Illinois. The offices to be voted on are President and Vice President of the Confederation (currently Dr. Bob Buckman and Bob Fischer); and two at large Director Positions (currently held by Allen Panek and Marcia Straub). Marcia Straub is eligible to run again for her current position.



A nominating committee will be formed at the March 23rd General Meeting and will prepare a slate of recommended candidates to be announced at the April meeting. Nominations will also be accepted from the floor at the General meeting. Any person who, at the time of the election, is a member of a homeowners association which is a Confederation member, or, in accordance with the amended bylaws an individual member in good standing, may seek and hold

office on the Confederation Board of Directors; except that there shall be no more than one Confederation Officer or a total of two Confederation Board of Directors members from any one Confederation member association.

Duties of the positions to be elected are as follows:

President – shall be chief executive officer of the Confederation; shall preside at all meetings; shall be the chairperson of the Confederation Board of Directors; and shall be the custodian of the corporate records and seal. All records of Confederation business shall be and remain the property of the

Confederation. The President shall also ensure (and may delegate to other Board Members the direct responsibility to see) that all newsletters, notices to member associations, and other Confederation communications, are promptly sent and distributed in a timely and appropriate manner and shall ensure that the Secretary is provided, in a timely and appropriate manner, copies or other adequate information on all such communications.

Vice President – shall assume all duties of the President in the event the office of President becomes vacant for any reason,



and shall perform such other duties as assigned by the President of the Confederation Board of Directors.

At-Large Board Members – shall be chairpersons of Ad Hoc Committees of the Confederation as formed at the discretion of the BOD. They shall be eligible to assume the terms and duties of Confederation officers, if such officers resign, refuse, become ineligible, or are otherwise unavailable to fulfill their terms. At-Large Board Members shall be empowered to vote in all decisions of the BOD. If any elected Director is not able for any reason to complete a term of office, the BOD may appoint an Associate Director to serve as a Director until the next annual election and any individual so appointed shall be empowered to serve and perform their duties upon appointment.

All member associations in good standing are eligible to cast a vote in this election. To be considered in good standing, member associations are to be current in their annual dues. It is not necessary to be a Loaves & Fishes client to use this free community service. Discover Where Maple Syrup Comes From

Experience maple tapping and the making of maple syrup in all its stages at our annual Maple Tapping & Pancake Breakfast. - Start your adventure with a hike down Thornhill Trail to our tapped sugar maple tree, where you can see for yourself how sap flows from the tree and is collected. "Even parents are impressed to see the sap dripping from the tree," says Jane Warfel, youth and family programs coordinator. You can even taste the sap right there at the tree.

Its taste may surprise you, says Lesley Kolaya, manager of youth and family programs. "The sap is very watery tasting, with a hint of flavor. Tasting the sap gives you an appreciation for the rest of the process." While you're at the maple tree, look for the tree's scars from past tappings.

Next, travel down the trail to the auger demonstration, where you learn how to safely drill into a maple without damaging the tree. It's a favorite stop for many kids, where you can try your own hand at the auger on a fallen log.

Then, head to the Shelter to see how sap is turned into the maple syrup we all know. As you learn about its history and nutrition, you can sample syrup at various points in the process.

Now that you've worked up an appetite, it's time for our pancake picnic. Pick up your four silver dollar pancakes with a side of bacon then grab samples of four different grades of syrup to taste, by themselves or on your pancakes. Find a seat by the roaring fire and enjoy.



The Government Finance Officers Association of the U. S. and Canada (GFOA) recently awarded the Park District with the Certificate of Achievement for Excellence in Financial Reporting for its 2011 Comprehensive Annual Financial Report.



According to GFOA, the Certificate is the highest form of recognition in the area of governmental accounting and financial reporting. The Naperville Park District has received this Certificate annually since 1991.

The Certificate for Excellence in Financial Reporting is awarded by an impartial panel "to meet the high standards of the program including demonstrating a constructive 'spirit of full disclosure' to clearly communicate its financial story," said representatives from the GFOA in a Feb. 6, 2013 press release.

The Naperville Park District recently received a report from Shaw Environmental summarizing the results of **soil**, **groundwater**, **surface water and sediment testing at Sportsman's Park**. The Park District then submitted this report to the Illinois Environmental Protection Agency (IEPA) Site Remediation Program (SRP).

The report, known as a *Focused Site Investigation Report* (FSIR), was completed in conformance with the IEPA approved Site Investigation Work Plan (dated January 2012) and Title 35 of the Illinois Administrative Code Part 740. This FSIR seeks IEPA concurrence regarding the delineation of the nature and extent of contamination. The FSIR summarizes the results of 303 soil samples, 9 groundwater samples, 12 surface water samples and 48 sediment samples.

In general, the results of the assessment were consistent with previous investigations. Monitoring wells installed and tested at the Site did not encounter lead at concentrations exceeding IEPA

Groundwater and Drinking Water Standards. Lead was encountered within the trap shooting shot fall deposition zone and gun range at values exceeding the most stringent IEPA Remediation Objectives.

Upon regulatory concurrence of the FSIR, the Naperville Park District will proceed with the SRP required *Remedial Objectives Report* and the *Remedial Action Plan* in order to gain regulatory concurrence on appropriate remedial measures. To proceed with the next phase of the process, Shaw Environmental will submit a change order to the Naperville Park District Board of Commissioners to extend the scope of services.

At the February 14 meeting of the Naperville Park District Board of Commissioners, the Board expressed support for the idea to name the driving range at Naperbrook Golf Course the "Glen Ekey Driving Range." Following initial consideration of the naming proposal, the Board's policy requires a 60-day waiting period prior to a final vote to approve the naming.

Glen Ekey was an influential Naperville Park District director serving from 1981-1996 during a period of rapid growth in the community. The 1981 population of approximately 45,000 grew to 118,000 in 1996 with two golf courses and 123 parks encompassing 2,300 acres. Ekey had the vision to purchase on behalf of the District much of the park land that we enjoy today for outdoor recreation.

Once the naming becomes official the Naperville Park District plans to host an event at Naperbrook Golf Course in May 2013 to dedicate the range as the "Glen Ekey Driving Range."

Volunteer tax preparers in the AARP Tax-Aide Program will provide **free tax filing assistance to seniors** by appointment only at the Alfred Rubin Riverwalk Community Center, 305 W. Jackson Ave., through April 10, 2013.

Those interested in scheduling a 45-minute appointment for tax assistance may call the Naperville Park District at 630-848-3613. Membership in AARP is not required. Additionally, tax assistance is available to homebound seniors by calling 630-848-3613.

Like thousands of other volunteers across the country, the local AARP Tax-Aide volunteers complete training courses in aspects of tax law with materials supplied by the Internal Revenue Service (IRS). The volunteers provide free electronic filing services using IRS software that also is used by many paid professionals.

Individuals who register for tax assistance are asked to bring all necessary paperwork to their appointment, including the following:

- Last year's tax return and tax records
- Social security or Tax ID number for self, spouse, and dependents
- Checking account routing number for direct deposit information
- Income documents, including W-2, 1099, K-1, etc.
- Information about tax-deductible items, including dependents, interest, real estate tax bill, state tax bill, charitable donation receipts, etc.

Tax assistance is one of many free and low-cost programs for seniors offered by the Naperville Park District. Hours at the Nichols Library on Sundays will be extended starting March 3. This temporary extension will add four more hours, allowing the library to be open from 1 to 9 p.m. The increase in hours is a pilot program, explains John Spears, Naperville Public Library Executive Director. "The public has requested expanded hours for many years, and we will run this program for four months to gauge potential use." Spears explains. "Sunday is our busiest day, and in looking at the experience of other libraries, adding evening hours on Sunday has proven very effective in meeting the public's

demand for more services. Several years ago we shortened Sunday hours due to budget cuts. During budget discussions last fall, City Council asked what it would cost to extend our hours."

Hourly usage statistics will be carefully examined throughout the process. "We'll see if it meets the public's needs. If it does we'll have the information necessary to decide the appropriate staffing levels to make the extended hours permanent," Spears said. With Board and Council approval, these figures would then be incorporated into the fiscal year 2015 budget, and the longer hours would be fully implemented in May 2014

The public can now **scan and fax items** on new equipment that has been installed at all three Naperville Public Library buildings. The Scan Station machines are located in the Computer Lab at the Nichols Library, near the Lower Level Conference Room at the Naper Boulevard Library, and near the upper level copiers at the 95th Street Library

The new machines also make the scanning process more convenient. Since they are standalone machines there is no need to log into the system in the Computer Labs. In addition at the Scan Stations you can scan documents to Google docs, email, a USB drive or even print the scan.

Scanning documents is free, faxes cost \$1/page to the U.S. and Canada, \$2 to other international locations and printing costs 10 cents/page for black & white; color copies are 25 cents/page
